# National Geographic Names Ulaanbaatar Among Top Twenty Destinations for 2011

Ulaanbaatar, Mongolia was selected by National Geographic as one of the top twenty trip destinations for 2011. According to their description, as the cultural, economic, and transportation hub on the Tuul River, Ulaanbaatar is the starting point for two-humped Bactrian camel treks and other exotic Gobi desert expeditions, but its ten museums, close proximity to national parks, and collection of imperial palaces and Buddhist monasteries qualify Ulaanbaatar as a destination rather than way station.

#### "Poets of Mongoila" Film by a Belgian Filmmaker

"Poets of Mongolia" is structured around the transformation of coal into energy in Nailakh, a small city at the edge of Ulaanbaatar. The film evokes the meaning of poetry in the daily life of ordinary people who are trying to cope with the harsh reality in a rapidly changing world. Through poetry a miner praises nature, a heating technician evokes man's destiny, a blind singer expresses her wish to see and an expat finds the strength to survive in a foreign country. The filmmaker Peter Brosens directed and produced the internationally acclaimed "Mongolia Trilogy," consisting of the documentaries "City of the Steppes" (1993), "State of Dogs" (1998) and "Poets of Mongolia" (1999). "Ханы Золотой Орды (Khans of the Golden Horde)," Pochekayev, Roman Ulianovich (2010), Evraziia. The book gives biographical account of Batu khan, the factual founder of the Horde, Mengu-Tumur, the official khan, Mamai who tried to preserve the unity of the state during turmoil and Tokhtamysh who united the horde briefly, Ulug-Muhammed, the founder of Kazan's khanate, Ahmat under whom Russia was released from taxation and eight more rulers who left their mark in history.

"Chosun and the Mongols: Understanding of the Mongols Represented in the Travel Books of Choi-Dukjung, Park-Jiwon, Seo-Hosoo," Pak, Won-gil (2010).

"Wild Rangelands: Conserving Wildlife while Maintaining Livestock in Semi-arid Ecosystems," edited by Johan T. du Toit, Richard Kock, James C. Deutsch (2010), Wiley-Blackwell. This book examines the pressures on rangeland ecosystems worldwide from human land use, over-hunting, and subsistence and commercial farming of livestock and crops. Leading experts have pooled their experiences from all continents to cover the ecological, sociological, political, veterinary, and economic aspects of rangeland management today.

"Japanese War Orphans in Manchuria: Forgotten Victims of World War II," Itoh, Mayumi (2010), Palgrave Macmillan. The book provides historical examination of Japanese migration campaigns, diaspora, Japanese farmer settlers, repatriation and international politics of Imperial Japan before the collapse of Qing rule.

"Popular Religion and Shamanism," edited by Ma Xisha, Meng Huiying (2011), Brill. Part I: 'Popular Religion' discusses the evolution of organized lay movements over ten centuries. Part II: 'Shamanism' reflects the revived interest of scholars in traditional beliefs and culture that reemerged with the "open" policy in China in the 1970s. Two of the essays included in this section address shamanism in northeast China, where the traditions played an important role in the cultures of the Manchu, Mongol, Sibe, Daur, Oroqen, Evenki, and Hezhen.

"Esoteric Buddhism and the Tantras in East Asia,"edited by Charles D. Orzech, Henrik H. Sørensen, Richard K. Payne (2011), Brill. "Esoteric Buddhism" had the greatest geographical spread; it left its imprint not only on its native India, but also on Southeast Asia, Central Asia, Tibet and Mongolia, as well as China, Korea and Japan. This volume, the result of an international collaboration of forty scholars, provides a comprehensive resource on Esoteric Buddhism and the Tantras in their Chinese, Korean, and Japanese contexts, from the first few centuries of the Common Era up to the present.

"The Constitution and Contestation of Darhad Shaman's Power in Contemporary Mongolia," Judith Hangartner (2011), Brill. This book offers an in-depth insight into post-socialist rural shamans in Mongolia, a rare but important contribution to the ethnography of both Inner Asia and Southern Siberia. It examines the social

making of shamans, in particular those of the Shishget depression of the northernmost borders of Mongolia. By analyzing practices, discourses and performances in local and national arenas, the author traces the social constitution of the shamans' inspirational power, examines the shamans' performance of power during the seance, discusses the economy of reputation of successful shamans and scrutinizes their legitimizing practices.

"The Bulgars and the Steppe Empire in the Early Middle Ages: The Problem of the Others," Tsvetelin Stepanov, translated by Tatiana Stefanova, Tsvetelin Stepanov (2010), Brill. This book is about the Eurasian steppe and China, Persia, Byzantium, as well as the 'Inside' and 'Outside' Other. This dual approach helps the reader better understand the attitudes of those who live in the Steppe toward their southern, sedentary neighbors (in this book, the 'Outside' Other) and to the women and shamans/magicians within the nomadic confederations (in this book, the 'Inside' Other), during the so-called 'Golden Age' of the Steppe Empire between the sixth and ninth/tenth centuries.

"One Hundred Thousand Moons: An Advanced Political History of Tibet," Tsepon Wangchuk Deden Shakabpa, translated and annotated by Derek F. Maher (2010), Brill. The author situates Tibet's relations with a series of Chinese, Manchurian, and Mongolian empires in terms of the preceptor-patron relationship. Simultaneously, this volume serves as an introduction to many aspects of Tibetan culture, society, and especially religion. The book includes a compendium of biographies of the most significant figures in Tibet's past.

"Mongol ulsyn niislel Ulaanbaatar khotyn tuukh, soelyn dursgal (Historical and Cultural Monuments of Ulaanbaatar City, Capital of Mongolia)," Gankhuyag, Oyuuny (2010), Nom Khur. The book features articles about historical and cultural monuments of Ulaanbaatar City.

"Khanty, People of the Taiga: Surviving the Twentieth Century," Andrew Wiget, Olga Balalaeva (2011), University of Alaska Press. Drawing on nearly twenty years of fieldwork, as well as ethnohistory, politics, and economics, this volume takes a close look at changes in the lives of the indigenous Siberian Khanty people and draws crucial connections between those changes and the social, cultural, and political transformation that swept Russia during the transition to democracy.

"From the Yenisei to the Yukon: Interpreting Lithic Assemblage Variability in Late Pleistocene/Early Holocene Beringia," edited by Ted Goebel and Ian Buvit (2010), TAMU Press. The twenty chapters explore how Beringians adapted in response to climate and environmental changes. By examining and analyzing lithic artifacts, geoarchaeological evidence, zooarchaeological data, and archaeological features, these studies offer important interpretations of the variability to be found in the early material culture the first Beringians. The scholars contributing to this work consider the region from Lake Baikal in the west to southern British Columbia in the east.

"Contemporary Anthropology of Religion: Explorations in Siberia and Beyond," Marjorie Mandelstam Balzer (2010), Palgrave Macmillan. Personal experiences with shamans are based on extensive fieldwork in several areas of Siberia and the Far East, including Khanty, Sakha, Tuvan and Buriat regions. The author outlines shifting ways that healers and healing communities are creating effective yet altered ritual environments, transcending harsh legacies of Soviet and missionary repression. Providing new angles on our understanding of the intersections of spirituality, religion and politics, she uses narratives about shamans to probe social and political issues of post-socialism, modernity, authenticity and indigenous rights.

"The Genealogical Construction of the Kyrgyz Republic: Kinship, State and Tribalism," David Gullet (2010), Global Oriental. This book explores the conceptions of genealogy, kinship and 'tribalism' in the intertwined construction of personhood and national identity in the Kyrgyz Republic. It makes an important contribution to several theoretical and regional debates. Genealogy, a central theme of the work, is explored not only as an analysis of relationships, but also as a methodological tool through which to examine society. The book contributes to theories of kinship and the state.

"The Monguors of the Kansu-Tibetan Frontier," Louis J. Schram (Republished 2010), LuLu. Republication in a single volume of Schram's classic study of the Monguor, with new introductions by Juha Janhunen, Paul Neitupski, Gray Tuttle, Keith Slater, Jeroom Heyndricks, Limusishiden and Kevin Stuart.

"Lonely Planet Mongolia (Country Guide), Michael Kohn, Dean Starnes (August, 2011), Lonely Planet. New edition of the best-selling guide toMongolia.

"Law, Policy and Practice on China's Periphery: Selective Adaptation and Institutional Capacity," Pitman B. Potter. This book examines the Chinese government's policies and practices for relations with its peripheral areas (Tibet, Xinjiang, and Inner Mongolia, Hong Kong and Taiwan). It focuses on themes of political authority, socio-cultural relations, and economic development.

"Flowers of Mongolia," Michael H. Hauck, Zeerd-Aduuchid B. Solongo (2010), Verlag Rüdiger Biermann. In this book about the flora of Mongoliamore than 1000 color photos of more than 400 species of vascular plants belonging to more than 70 families are presented. The introduction is written in English, Mongolian and German. The appendix in English indicates information about the distribution, the locality where the plant was found, and about synonyms. Scientific names of the plants were used as well as the Mongolian names of the plants.

"Xinjiang and the Expansion of Chinese Communist Power: Kashghar in the Twentieth Century," Michael Dillon (July, 2011). This book focuses on the key city of Kashghar, the symbolic heart of Uighur society, drawing on a large body of records in which ordinary people provided information on the period around the communist takeover. Subjects covered by the book include work, government, the built environment, religion, culture and politics.

"Representing Power in Modern Inner Asia: Conventions, Alternatives and Oppositions," edited by Isabelle Charleux, Grégory Delaplace, Roberte Hamayon and Scott Pearce (2010), Western Washington University Press. The proceedings of an international symposium 'Representing Power in East Asia: Legitimizing, Consecrating, Contesting' held in Paris in March 2006. The symposium was organized within the framework of an agreement between the École Pratique des Hautes Études (Centre d'études mongoles et sibériennes) and the University of Cambridge (Mongolia & Inner AsiaStudies Unit), as a continuation of a symposium on 'Inner Asian Statecraft and Technologies of Governance' held in Cambridge in March 2004.

"Representing Power in Modern Inner Asia: Legitimacy, Transmission and the Sacred," edited by Isabelle Charleux, Grégory Delaplace, Roberte Hamayon and Scott Pearce (2010), Western Washington University Press. This book was also published as a result of an international symposium 'Representing Power in East Asia: Legitimizing, Consecrating, Contesting' held in Paris in March 2006.

"Mongolia Economic Retrospective: 2008-2010" (2010), World Bank Publications. Although the economy has rebounded since the end of 2009 and the successful negotiation of the Oyu Tolgoi (OT) mining project has helped transform Mongolia's medium to long-term economic outlook, there remain sizeable policy challenges. In particular, the looming mining boom brings the risks of 'Dutch disease' to Mongolia. In the near term, significant fiscal financing risks remain until revenues from OT are realized. In particular, this Retrospective discusses the need for continued fiscal consolidation and how the adoption of the planned fiscal stability law should help manage the upcoming mining boom. Meanwhile, ongoing solvency problems in the banking sector need to be resolved quickly and transparently to prepare the sector for the upturn in economic activity.
